- hunter/jumper warm up ring was redone by Downie at no cost with the old pile of sand from the dressage ring. We still have a VIHAR credit of \$515.46. Downie suggested he would redo the round pen in the spring.
- 7.2 Year Ends Awards: tabled
- 7.3 Grounds rental: Gina proposed to increase grounds rental fees at the August meeting:

\$150/day indoor arena + round pen
\$100/day any one of the outdoor arenas
\$550/day whole grounds (incl. show office)

Ron made the motion to accept the new rates above, Anika 2nd, AIF.

- Stall fees with grounds rental will remain \$10/night
- Ron motioned following changes:
 - \$25/day old jumps rental, damage deposit \$200
 - \$25/day trail & gymkhana equipment, dd. \$200
 - \$25/day show office rental with one arena
 - \$50/day concession booth rental
 - (arena groomer \$200/for all rings + power hook up \$20/day remains the same)

- 8.1 Bingo 2015/2016: Erin will apply for gaming license. Need at least 5 volunteers each time. Gina to look after sponsors again?
- 8.2 Geri proposed using schooling show profit to sponsor one child for a clinic of choice. Schooling shows don't always show profit, clinic costs vary, child's riding abilities vary, who would pick which kid? We used to have bursaries which were hardly used, many points were made, needs further discussion.

- 8.4 Clinic fees: Motion made by Downie, 2nd by Leslie: Clinic fees should be raised to \$15/non-member, free for members. Tabled until next meeting.
- 8.5 Drop in fee for overnighters: Leah suggested a drop-in membership fee for out-of-town overnighters. They can pay an additional fee of \$10/day (on top of the stabling fee) and would be allowed to ride in the NSC arenas, providing they have HCBC insurance. This is only for people passing through, not a drop in fee for locals. To be decided at AGM in February 2016.
